The foundation of many state- and territory-wide sexual assault coalitions is their membership. As coalitions grow and respond to emerging issues in the field, so too does the membership structures of coalitions. Our membership helps us create a network and involves more people in leadership of the coalition and state / territory anti-sexual assault movement.

- b) Exposing the roots of violence in the institutionalized discrimination against women, children and those who are viewed as having less power; and
- c) Assuring that the person(s) being served has the ultimate determination as to whether, when, what, and how they access services and/or resources provided by the agency or entity; and
- d) Providing quality service through cooperative means; and
- e) Providing service regardless of the income of the person(s) being served; and

f) Establishing and sustaining training and education for persons responding to and/or providing services to victims/survivors of violence.

California Coalition Against Sexual Assault

CALCASA has recently updated our membership and affiliate programs to better support our primary membership base and to cultivate new affiliate partners, as the landscape surrounding sexual violence changes.

Membership – California Rape Crisis Centers

CALCASA's membership is held on an annual basis for the period of January 1 — December 31 and can be renewed each year. Any membership applications or renewals received after November 1 will be applied for the following year's membership.

Affiliate Program- CALCASA's Affiliate program consists of three levels: ORGANIZATIONAL, INDIVIDUAL, and STUDENT.

Colorado Coalition Against Sexual Assault

- Training- CCASA provides training, education, and technical/staff support on a variety of topics
 to members, at no or discounted cost. We design new trainings on an ongoing basis in order to
 meet members' needs; offer web-based training opportunities to save time and resources; work
 closely with other organizations and agencies in Colorado, as well as statewide coalitions in
 other states, to bring their experience and expertise to you; and seek to create a speakers
 bureau of experts in specific fields, or with particular knowledge, relevant to sexual assault
 services and prevention programming.

Kansas Coalition Against Sexual & Domestic Violence

All member programs pay \$1,000 annually for dues.

Member Program Support: KCSDV provides assistance, support, and accreditation for its member programs. These programs provide support services to survivors of domestic violence, dating violence, sexual assault and stalking. They serve all 105 counties in Kansas. KCSDV's program support includes:

*We do not have a membership structure outside of accredited programs though we have had in the past. When we started fundraising efforts for the coalition, our membership structure for non-service providers merged with our donors. Now, outside of the accredited member programs, basically, if you give \$\$ to KCSDV, you are treated as a donor, not a member.

Kentucky Association of Sexual Assault Programs

Our membership is simple. We are comprised of Kentucky's 13 designated rape crisis centers. Per state legislation, we have designated rape crisis centers for our area development districts. Each of those

centers chooses a person to serve on the KASAP board. Usually the board member is the ED of the program. The board votes on the membership "dues" amounts. I believe it is currently about \$1500/year. Those funds support anything our grants won't cover.

Benefits – the KASAP staff provide technical assistance and support to all programs as needed. As a pass-through agency, we provide programmatic and financial monitoring. We provide support, guidance, training, etc. to help programs maintain regulatory and contract compliance and to support continuous quality improvement. We find or develop resources as the programs need and facilitate their sharing resources with one another. We also develop and host an annual conference that provides workshops on issues specific to programmatic staff needs.

Jane Doe Inc.

Membership Criteria and Benefits:

Member Organizations are non-profits that further the mission of Jane Doe Inc. by providing services to or on behalf of survivors of domestic violence and/or sexual assault. These services are free, confidential, and available to all survivors regardless of age, race, gender, gender identity, religion, sexual orientation, physical ability, or financial status.

CRITERIA: The criteria for membership has been determined by the member organizations themselves in conjunction with Jane Doe Inc.'s Board of Directors. There are two levels of membership and applying is a process; all members agree to support a set of core values that guide our collective work.

Core Members provide comprehensive services and meet one or more of the following criteria:

- 1. Emergency shelter with 90-day stay or safe homes with a minimum of 3-day stay.
- 2. Programs for victims of domestic violence with 24-hour accessibility.
- 3. Rape crisis centers that provide a range of services such as a 24-hour hotline, counseling, medical advocacy, legal advocacy, and prevention education.
- 4. Transitional living programs that provide residential services specifically designed for victims of domestic violence.

Core members must also sign and support the principles of unity which address the mission and core values of Jane Doe Inc. They must also agree to support a unified budget strategy for public funding at the state and national level.

General Members provide intervention or prevention services, but do not meet the criteria for Core Members. They include prevention programs, hospital and school-based programs, batterer's intervention programs, faith-based and other special focus programs, and others.

Montana Coalition Against Domestic & Sexual Violence

Since its inception, a key portion of the MCADSV mission has been to support the efforts of our members to offer professional, appropriate assistance to victims and survivors of domestic and sexual violence in their community. To that end, we provide our members with regular technical assistance, training, and opportunity to network with one another and share best practices. Below are some of the specifics:

- We provide information to our members that include information about trainings/conferences, grants/funding, articles of interest, best practices, etc.
- We offer specialized trainings to our members in their communities.
- We host networking opportunities through membership meetings and an annual conference.
- We also provide technical assistance to members via the phone or e-mail, conducting research for them, or providing them with training/advocacy materials that we've developed or that have been developed elsewhere and purchased by MCADSV.

Organizational Membership - \$250

Open to domestic and sexual violence programs, victim witness programs and other nonprofit or public organizations with an interest in addressing domestic or sexual violence.

Individual Membership - \$50

Open to staff, volunteers, board members of domestic and sexual violence programs, victim witness programs, other nonprofit or public organizations with an interest in addressing domestic or sexual violence.

Nevada Network Against Domestic Violence

Program Membership: for programs whose primary services are for victims of domestic violence (click here for a list of our current Program Members). One of NNADV's main purposed is to support direct-service programs across the state. Our program members have access to all of NNADV's resources, including, grant funding and project support, telephone interpreting services, our program member intranet, technical assistance and training, educational materials, and resources library, as well as all other member benefits. We work with our program members to ensure our annual dues do not prevent them from benefiting from NNADV's support and services.

Program Membership: Typically, dues for our program members are either 4% of their state domestic violence fund grant or 2% of their domestic violence budget.

Organizational Membership: non-voting organizations that provide domestic violence assistance, though not necessarily direct assistance, in their communities. This type of membership is meant for organizations whose primary services may not be only for victims of domestic violence. These organizations may work with victims or their families (for example, law enforcement organizations) or may simply support the goals and philosophy of NNADV. Our organization members have limited access to technical assistance and training support from NNADV staff. They also have access to regional trainings, our quarterly newsletters, and all of our educational materials and resource library. We encourage representatives from Organizational Members to participate on the NNADV Board or Board Committees.

Dues for organization members are \$200 annually.

Individual Membership: for those in communities throughout Nevada who support the goals and philosophy of NNADV. These members have access to our educational resources, resource library, newsletter and regional trainings. They may also participate on the NNADV Board or Board Committees.

Dues for individual members are \$35 annually or \$10 annually for seniors or students.

New Hampshire Coalition Against Domestic & Sexual Violence

The New Hampshire Coalition Against Domestic and Sexual Violence (NHCADSV) seeks to create safe and just communities through advocacy, prevention and empowerment of anyone affected by sexual violence, domestic violence and stalking. In order to accomplish this mission, the NHCADSV has member programs who are dedicated to providing services to victims (both primary and secondary) and to the community at large. The NHCADSV's board of directors, staff and member programs work together to influence public policy on the local, state and national levels; ensure that quality services are provided to victims; promote the accountability of societal systems and communities for their responses to sexual violence, domestic violence and stalking; and work to prevent violence and abuse before they occur. The membership process has been developed to assure that member programs within the NHCADSV provide a consistent standard of service that is unduplicated within their community. This process also assures that funding that is received for services from federal, state, and other resources is fairly allocated to programs that are providing these services to their communities. These funds are not allocated to programs unless they are full members of the NHCADSV.

Membership Requirements

A. To be eligible for consideration for membership, the applicant must:

be a private, not-for-profit, non-governmental 501(c)(3) organization that meets the criteria set forth in the New Hampshire Nonprofit Checklist (available in the New Hampshire Center for Nonprofits' online resource center – http://www.nhnonprofits.org/content/nh-nonprofit-checklist), or be a program of such

- an organization (member programs funded by the NHCADSV prior to the adoption of this policy are exempt from this requirement);
- have a mission describing the provision of domestic and sexual violence and stalking services; and
- currently meet the requirements of the NHCADSV Program Standards for delivering services or have a reasonable plan with a timeline for how these requirements will be met.

B. If the applicant is located in the catchment/geographic service region of an existing member program, the applicant must also establish that acceptance of the applicant will not result in any duplication of services within the geographical area in which it is providing services. This requirement may be waived if the NHCADSV determines that an underserved population will be better served by an organization with special programming in that geographical area; the applicant must present a strong case for its ability to meet the underserved population's needs. Member programs funded by the NHCADSV prior to the adoption of this policy are exempt from this requirement.

Benefits of Membership The benefits of membership include, but are not limited to:

- allocation and monitoring of federal, state, and other funds for victim services;
- statewide awareness raising;
- ongoing technical assistance and support;
- specialized training and resources;
- shared learning and peer support;
- dissemination of best practices and current resources; and
- statewide collaboration with allied organizations including legal assistance organizations, child protective services, child advocacy centers and others.

In addition, member programs have the benefit of the NHCADSV's advocacy on the state and national level, including but not limited to:

- working with the state government to create and defend effective laws and policies to support victims;
- providing leadership in national organizations to promote funding, laws and policies to benefit victims; and
- participating on statewide boards and commissions to advocate for effective responses to victims.
